

ALTCAR RENT-A-CAR

Contract For A Car Hire

- 1/. The user shall return a car, undamaged, in a good working condition, with the complete equipment (a spare wheel with a jack, a wheel key, a triangle, a fire extinguisher and anti-theft protection if there is such a need) along with the appropriate documents at the place indicated in this contract.
- 2/. Each prolongation of the hire period requires the approval in writing or by telephone of the agent of the ALTCAR RENT-A-CAR, no later than 24 hours before the contract termination.
- 3/. In case of an unagreed prolongation of the hire period, the ALTCAR RENT-A-CAR is authorized to collect the extra charge amounted to 100% of the basic rate for the whole hire period, and the fact of seizure of a car to be reported to the police.
- 4/. At the time of returning a car, the amount of fuel in the tank should be the same as at the time of taking a car, otherwise, the user shall bear the cost of the difference in amount of the fuel.
- 5/. The car can be driven only by the person mentioned in this contract or if a user is any firm - the authorized person can drive the car.
- 6/. Every time, when the user gets of the car, he (she) must remember to close the door.
- 7/. Leaving in the car the car keys, documents, navigation and other valuable things, which might provoke any thief, is strictly forbidden.
- 8/. The hired car cannot be used for transport of persons or things on the sub-hire basis or the transport service, for transport of the objects exceeding the load capacity of the car and objects that might damage the car.
- 9/. The hired car cannot be used in races or sport competitions.
- 10/. The user of a car must obey all provisions defined by the insurer of this car.
- 11/. The user will incur the cost of any damage, uncovered by the insurance and the damage at the amount below 1000 PLN.
- 12/. The user assumes the pecuniary responsibility for a damage occurred due to a lack of protection of a car, by negligence, for the documents necessary for removal of a damage and for any destruction and damage caused by an unauthorized service and operation of a car.
- 13/. The losses caused by the idle of a car during a repair or removal of a damage are covered from the guarantee deposit by the insurer at the amount of 50% of the basic rate and the costs that have not been covered by the insurance. The guarantee deposit is non-returnable in case of a culpable loss of a car, a lack of documents necessary for liquidation of a loss, and other damage that occurred during a car operation, incorrect to its destination, the road traffic rules or the hire conditions.
- 14/. The guarantee deposit can be repayable if the perpetrator of the accident is a third party and the liquidation of a loss is realized from the perpetrator's civil liability policy. The guarantee deposit can be repaid after the perpetrator's insurer has confirmed the realization of the loss liquidation from his (her) civil liability policy.
- 15/. In case of a collision, the user will notify immediately the agent of the ALTCAR RENT-A-CAR and the police and will make an after-accident record, giving a particular description of the accident circumstances.
- 16/. If at the time of an accident the driver – the user of a car was found to be under the influence of alcohol or drugs (or the prescribed medicine, which taking does not allow to drive motor vehicles), the ALTCAR RENT-A-CAR reserves a right to the additional damages for suffering losses.
- 17/. If the vehicle has been excluded from the operation due to the causes independent of the user, this vehicle will be replaced with a new one. If such replacement is impossible, the user will get the repayment for an idle term.
- 18/. If a car needs a repair during the hire period, the user is authorized to sign and receive the VAT invoice in the name of the ALTCAR RENT-A-CAR.
- 19/. If a car is returned earlier, before the termination of the contract validity, the amount collected for the car hire is not repayable.
- 20/. The charge for the car hire including the guarantee deposit shall be made in advance for the whole period covered by the contract on the date of giving a car to the user.
- 21/. The charge will be collected in case of a delay in the return of a car: up to 12 hours – 50 PLN, over 12 Hours the same amount as for 24 hours.
- 22/. The user authorizes the ALTCAR RENT-A-CAR to make out the VAT invoice for the hire a car, without the user's signature.
- 23/. Driving the hired car outside the Republic of Poland is forbidden without the special permit in writing issued by the ALTCAR RENT-A-CAR.
- 24/. The user of a car must be at the age of 25 years and have been a bearer of the driving licence for at least 3 years.
- 25/. Smoking or using other stimulants in a car is strictly forbidden.

26/. The user shall pay a fine for any offence caused by hired car, occurred during the hire period of this car.

27/. The guarantee deposit (100%) is repaid at the time of giving back the car, undamaged, with the same amount of fuel as it was at the time of taking the car.
